Quick Guide

### WHO CAN EXHIBIT



Tech Startups

Limited to startups founded after January 1, 2018



Legal Entities that Support Startups

Join individually or organize pavilions with multiple startups



Corporate Venture Capital (CVC)
Investing in Startups

Must exhibit in a pavilion format with their startup partners

COMPUTEX exhibitors meeting the above criteria may also join InnoVEX



## **EXHIBITOR IDENTITY**



## Individual Startup

- Exhibitor must be the startup itself
- Must meet the startup founding year requirement



#### Pavilion Organizer

- Includes multiple startups
- The pavilion organizer will complete the registration on behalf of the entire pavilion
- Each exhibiting startup must create a My InnoVEX account and complete the exhibitor profile by April



## THE BOOTH TYPES



- Image: 2025 version, provided for reference only.
- All include 110V/500W basic power.
- Stand and Shell Scheme booths follow the organizer's design; custom designs require pre-approval.

- For Taiwanese exhibitors, please refer to the official website for the price in Taiwan dollars.
- 30% deposit within 14 days after registration
- Wire transfer only; Amount must be remitted in full, without deductions.



#### HOW TO REGISTER

Register Online from Sep. 22, 12:00 (GMT+8)

Register on the InnoVEX website via your My InnoVEX account. Earlier registration = earlier booth selection priority.

2 Pay Booth Fee Before Feb. 5

A 30% deposit must be paid within 14 days after registration.

Unpaid or overdue entries will lose booth selection eligibility and be cancelled.

If no booths are available when you register, no payment is required until notified.

3 Attend Booth Selection Meeting in Early March

The Individual exhibitors and pavilion organizers should attend the meeting. Overseas exhibitors must send local representatives.

If absent, booth location will be assigned by the organizer.

Complete Your Profile Online By Mid-April

InnoVEX Online exhibition will start from May 1.

Pavilion startups must complete individual profiles via My InnoVEX to be listed as exhibitors.

Exhibitors who cancel before Feb. 10 may apply for a full refund. After Feb. 10, no refunds will be provided.



#### PAVILION REGULATION

#### **Numbers of Startups Under Pavilion**

- Max exhibiting startups per pavilion = 3 x 1 booths (e.g., 3 booths = 9 startups)
- for CVC Pavilion -
  - The number of Startups must occupy at least 50% of the booths.
  - Each startup gets a minimum 1.5 x 1.5 m space with its own booth or display table

For example, A pavilion applies for 9 booths, and the acceptable number of co-exhibited startups is 5-27.

#### **Other Regulations**

- Each startup may exhibit up to 2 locations (pavilion or individual booth).
- The pavilion host must submit the exhibition plan to the organizer for approval.
- Pavilion startups must complete the online registration individually to be listed as exhibitors, featured on the official website and promotional materials, and be eligible for free registration in the Pitch Contest, matchmaking system, and the Night Party.
